After their mothers death, all three girls were involved in theft of one kind or another. Margaret was only

caught once (with Susan) and managed to remain in Scotland. Doesn't appear to have married. Mary and Susan were caught several times before being transported for seven years to Van Diemens Land (Tasmania, Australia)

Mary Ann Robb, daughter of Charles Robb, porter of Dundee was convicted of robbery on 4th May 1835. She was transported on the "Hector" departing London on 11th June and arriving on 20th October 1835.

Susan Robb, daughter of Charles Robb, porter, Whitehall Close, Dundee, was convicted at High Court, Perth 30 Sep 1839. Transported on the Gilbert Henderson in November 1839, arriving 14th December 1839.

Both girls married and had children and both lived in Launceston, Tasmania at the time of Mary Anns death. Susan may have assisted Andrew with his young girls before she departed for the American gold rush in San Francisco in 1849.

Mary Ann Robb is my 3rd great grandmother
